A. Required Documentation and Timing

The Cash Dividend/Distribution notification must be provided to the Listing Qualifications Department at least 10 calendar days prior to the record date. Issuers are also required to provide public notice of the distribution action using a Regulation FD compliant method. Notice to the Listing Qualifications Department should be given as soon as possible after declaration and, in any event, no later than simultaneously with the public notice.
