All symbols being made available for trading, as referenced in this circular, must be submitted to the Exchange in the appropriate "symbol" field <u>without the use of a separate symbol-suffix field</u>, and must contain both the "root" symbol and "SIAC/CQS Suffix" value immediately following the "root". In

addition, these symbols must follow the "Preferred", "Preferred Class 'A'" and "Preferred Class 'B'" Suffix examples above.

The Exchange <u>will ignore any value placed in a symbol-suffix field</u>, and only process the order or quote using the value contained in the "symbol" field.

## **Examples for FIX users:**

Tag 55 = AGOpB

\*\*\*Please note: CBOE does not process any value submitted in FIX Tag 65\*\*\*

<u>CMi users:</u> should continue to use the CBOE *direct* assigned Product and Class Key definitions to identify these product symbols.
