CFE TO LAUNCH REAL ESTATE INDEX FUTURES

- ► This week, CBOE Futures Exchange announced plans to begin offering futures contracts on several Radar Logic 28-Day Real Estate indexes (RPX) daily spot market equivalents for housing asset valuations covering major U.S. metropolitan centers pending regulatory approval.
- ► CFE's licensing agreement with Radar Logic Incorporated, a real estate data and analytics company that calculates RPX indexes on U.S. metropolitan centers, geographical regions and the broader U.S. housing market, would make way for CBOE Futures Exchange to offer futures contracts on a number of these indexes, including, but not limited to, those measuring real estate transactions in:
 - o **The U.S. as a whole The 25-MSA Composite** (includes metropolitan statistical areas MSAs for Atlanta, Boston, Charlotte, Chicago, Cleveland, Columbus, Denver, Detroit, Jacksonville, Las Vegas, Los Angeles, Miami, Minneapolis, Milwaukee, New York, Philadelphia, Phoenix, Sacramento, San Diego, San Francisco, San Jose, Seattle, St. Louis, Tampa and Washington, D.C.).
 - o **Four geographical regions** Midwest, Northeast, West and South
 - o Eight metropolitan centers Chicago, New York, Los Angeles, Las Vegas, Miami, San Francisco, Seattle and Phoenix
