RE: Restrictions on Transactions in
Volvo AB ("VOLV/VQY")

The NASD has suspended trading in shares of Volvo AB (VOLV/VQY) , on the opening of business on December 13, 2007.

Trading on the CBOE in existing series of VQY options is subject to the following restrictions. Only closing transactions may be affected in any series of VQY options except for (i) opening transactions by market makers executed to accommodate closing transactions of other market participants and (ii) opening transactions by CBOE member organizations to facilitate the closing transactions of public customers executed as crosses pursuant to and in accordance with CBOE Rule 6.74(b) or (d).

The execution of opening transactions in VQY options, except as permitted above, and/or the misrepresentation as to whether an order is opening or closing, will constitute a violation of CBOE rules, and may result in disciplinary action. Member organizations should ensure that they have appropriate procedures in place to prevent their customers from entering opening orders in this restricted option class.

There are no restrictions in place with respect to the exercise of VQY options. The provisions of this circular apply to any options on VQY traded on CBOE.
