

## **Regulatory Circular RG16-015**

To: Trading Permit Holders

RE: Restrictions on Transactions in Nuverra Environmental Solutions, Inc., (NES)

Effective January 20, 2016, Nuverra Environmental Solutions (NES) was delisted from the NYSE and moved its listing to the Other-OTC Market under the symbol NESC. Therefore, trading in NESC options will be subject to restrictions.

Trading on CBOE in existing series of NESC options will be subject to the following restrictions. Only closing transactions may be affected in any series NESC options except for (i) opening transactions by Market-Makers executed to accommodate closing transactions of other market participants and (ii) opening transactions by CBOE TPH organizations to facilitate the closing transactions of public customers executed as crosses pursuant to and in accordance with CBOE Rule 6.74(b) or (d).

The execution of opening transactions in NESC options, except as permitted above, and/or the misrepresentation as to whether an order is opening or closing, will constitute a violation of CBOE rules, and may result in disciplinary action. TPH organizations should ensure that they have appropriate procedures in place to prevent their customers from entering opening orders in this restricted option class. In addition, transactions in contravention of this restriction may be subject to nullification pursuant to Exchange Rule 6.25.

There are no restrictions in place with respect to the exercise of NESC options.
